Insurance Requirements

Insurance requirements: The applicant must provide insurance with a minimal limit of \$1 million combined single limit. The Certificate must be issued by insurance underwriters “admitted” by the California Insurance Commission with underwriters rate “A” or “B+” by Best’s Key Rating Guide. Proof of Workers Compensation is also required.

The certificate of insurance *and the Letter of Endorsement* (ISO form # CG-20-12-07-98 or AB-90-67-12-93 or equivalent) must name the City of La Quinta as an additional insured, as follows, verbatim:

Certificate Holder Box:

City of Coachella, its officers, City Council, agents, employees, and volunteers, 78495 Calle Tampico, La Quinta, CA 92253

Description of Operations box:

City of Coachella and its officers, City Council, agents, employees, and volunteers are additional named insured with respect to liabilities arising out of the performance of services hereunder.

Endorsement Page:

City of Coachella, its officers, City Council, agents, employees, and volunteers, 78495 Calle Tampico, La Quinta, CA 92253 are additional named insured with respect to liabilities arising out of the performance of services hereunder.

Proof of Workers Compensation Insurance is required

Aircraft/UAS Insurance:

If the use of aircraft is required, Aircraft liability insurance in the amount of \$10 Million naming the city as additional insurance is required, with an endorsement page. Use the required wording as listed above.

In the case of UAS/Drone use, Aircraft/UAS liability insurance in the amount of \$2 million naming the city as additional insurance is required, with an endorsement page. Use the required wording as listed above.



FILM/PHOTOGRAPHY PERMIT REQUIREMENTS

Applications should be submitted at **least 30-days prior** to the planned film shoot. Incomplete applications and applications submitted with less than 30-days for processing may not be reviewed and issued in time for the planned shoot.

Application must include the following items at time of submission:

- Application Form.
- Certificate of Insurance with the City of La Quinta listed as an additional insured.
- Proof of Workers Compensation Insurance as applicable. Permission letter signed by the owner or authorized agent of all private property covered under the permit.
- Copies of current City of La Quinta Business License for production company and all vendors that will work in the City.
- If any portion of the film shoot will take place on public property, a site plan should be included with the original application.

Please be aware that based on the scope of the film shoot, additional City Departments and outside Agency's may need to conduct reviews that may include additional cost and require more time to complete.
