- c. A map showing exactly what area(s) you are requesting – GPS coordinates are preferred
- d. A Certificate of Insurance **and** a Letter of Endorsement listing the **Bureau of Land Management** as additionally insured (Required – see page two (2) for details)

Please read and complete the aforementioned forms. **Any pages left unsigned or incomplete will halt the permit process and delay your permit.** Please use the checklist above to verify you have prepared all the appropriate documents. Once the **signed and fully complete** application has been received, along with required insurance documents and payment, the IEFS will process your permit within 30 working days. It is important to list **ALL** props, vehicles, and equipment to be used, along with a detailed description of your activities and/or a storyboard. You must list all stunts, precision driving, pyrotechnics, explosive devices, airplanes, helicopters or drones used in your shoot.

61+ people = \$600/day

Commercial Still Photography.....Permit Rates: 01-10 people = \$100/day

IEFS Fee+\$200 per permit

*Regulations (43 CFR 2920.6(b)) require the collection of cost recovery and monitoring fees for land use permits.

*to avoid this fee you can contact the BLM directly for permit processing – (760) 833-7100. This will also increase your permit processing time to 4 weeks or more.

All invoices will be sent via Square.com where you can pay online with a credit card or via ACH

If you want to pay by check, make it payable to the Inland Empire Film Services, Inc. Once you have been given your total, overnight (via FedEx, UPS, etc.) your check to the address supplied by the IEFS representative. Keep in mind that the check has to clear the bank before the permit will be issued.

You must provide proof of liability insurance and a Letter of Endorsement (ISO Form CG-20-12-07-98 or equivalent) naming the Bureau of Land Management as additionally insured for the amount of \$1 million.

The Insurance Certificate *must* read in the "Certificate Holder" Box *verbatim*:

The Insurance Certificate *must* read in the "Description of Operations" Box *verbatim*:

And

In the event of the use of aircraft (planes, helicopters, etc), an Aircraft Liability Insurance Certificate and Letter of Endorsement is required naming the Bureau of Land Management as additionally insured in the amount of \$5 million. *If you are using drones, an UAS/aircraft liability insurance in the amount of \$2 million is required along with your FAA drone documents and a POA with Aeronautical maps, copy of 107 cert and FAA drone registration.*

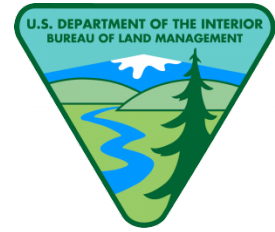

All vehicles to be used during filming must have displayed the approved permit on the front, driver's side dashboard. Also, a complete copy of your permit, stipulations, maps and insurance must be on site at all times.

Film Permit Stipulations
BLM Palm Springs-South Coast Field Office

1. Mecca Hills Wilderness is on both sides of Box Canyon. Filming activities are permitted within 200 feet from centerline of Box Canyon Road or up to the canyon walls if less than 200 feet. Activity must stay within pre-existing disturbance areas, no new disturbance or off road vehicle travel will be permitted. Use of the canyon walls and hills is excluded. Commercial; photography is permitted within 200 feet of the paved road.
2. No more than 4 vehicles are permitted on location.
3. Vehicles shall only park in previously disturbed areas devoid of vegetation.
4. Permittee shall provide BLM with certificate of public liability insurance (COI) in the amount of \$1,000,000.00 naming the Bureau of Land Management as additionally insured.
5. Vegetation shall not be removed, cleared or destroyed within the area.
6. Vehicles and/or equipment will not be allowed to block road access and will stay within road right-of-way and disturbed turnouts of the roads. (The Highway Patrol and County of Riverside should be notified for required permits).
7. Permittee is authorized to locate their vehicles within disturbed areas large enough to accommodate them without disturbing or destroying vegetation.
8. All trash or prop material associated with the project must be removed from the site at conclusion of filming.
9. Areas of sand/soil moved and recontoured by permittee shall be replaced and returned to as close to original state as possible to the satisfaction of the designated authorized officer of the Bureau of Land Management.
10. Permittee shall be held responsible for stipulations compliance by all parties associated with the permit.
11. Pyrotechnics are not authorized with this permit.
12. The permittee is required to keep a copy of this permit on site at all times for review by BLM personnel upon request. All persons (i.e., Permittees, contractors, sub-contractor, etc.) working at the site shall be familiar with the permit stipulations.
13. BLM will conduct site monitoring before and after the filming takes place.

14. Permittee shall supply their own drinking water and sanitation facilities. Absolutely no dumping of sewage or garbage on the ground is permitted.
15. Permittee shall leave the area in a condition satisfactory to the authorized officer of the Bureau of Land Management.
16. Any changes of site shooting location on public lands must be approved by the Authorized Officer.
17. Permittee shall be responsible for obtaining any required State and/or County permits or licenses. The permit authorizes the use of public lands under the jurisdiction of the BLM only.
18. Filming or recording BLM signs, including the Santa Rosa and San Jacinto Mountains National Monument sign, is prohibited.
19. Issuance of this permit does not constitute exclusive use of the public lands by the Permittee. Other permits may be issued within this permit area at the discretion of the Authorized Officer.
20. This permit may be revoked by the Authorized Officer for cause. The determination of what Constitutes cause will be decided solely by the Authorized Officer. There will be no refund of monies remitted by the Permittee for authorizations that are revoked by the Authorized Officer for cause. Examples of what may be considered cause include, but are not limited to, any violation of permit stipulations, interfering with other lawful users, unnecessary surface disturbance, and failure to follow the direction of any BLM employee directing and/or coordinating on-the-ground activities associated with this permit.
21. Filming operations shall be conducted in such a manner as to avoid creating safety hazards to other public lands visitors and users, and to the filming crews. The Permittee shall use whatever signs, flagging, help of individuals, or other appropriate safety devices for the safe conduct of the filming operation and the protection of other users and visitors before, during, and after filming activities. Props, equipment and vehicles that are left overnight at ongoing filming sites, must be accompanied by a guard and warning lights.
22. No person shall carry a weapon, including, but not limited to firearms and batons, during the performance of their duties or while acting in any way as an agent of the Permittee unless specifically authorized in writing by the Authorized Officer. It is the Permittees responsibility to ensure continued compliance with this stipulation.
23. You must receive prior approval from the Authorized Officer for the use of animals. Animals not endemic to the area shall be under the control of qualified animal handlers at all times. Animals shall not be allowed to feed on the natural vegetation. The Permittee

is responsible for providing appropriate weed-free feed immediately upon request to use the animal in filming and throughout the duration the animal is on public lands. The Permittee is responsible for providing water for the animals. All animal waste shall be removed from the public lands on a daily basis. Transmission of diseases from domestic animals to wildlife will be avoided through appropriate action 9 vaccines, avoidance of contact, etc.

24. Helicopters or fixed-wing aircraft will not be used during the filming project unless specifically authorized in the permit. If use is authorized, the Permittee shall provide on-the-ground traffic control, as well as other precautionary measures deemed necessary by the authorized officer to ensure public safety. Fueling of aircraft on public lands will not be authorized.
25. **Film companies planning to use drones** must use a company that has been granted an exemption by the Federal Aviation Administration (FAA); exempted companies are listed at this website:

http://www.faa.gov/uas/legislative_programs/section_333/333_authorizations/

You may also use an operator that has acquired the FAA Part 107 Certification. Filming companies must provide the BLM with a copy of the exemption/certification paperwork before a film permit can be issued for drone use.

26. Within **180 days after completion** of the filming operation, **the permittee is required to provide the BLM office with copies of prints and/or video depicting the project, as authorized by this permit.** This material will become the property of the BLM for use in developing a library to represent the types of filming activities that occur on the BLM public lands. 27. *For movie projects;* Acknowledgment through the film credits shall be given to: U.S. Department of the Interior, Bureau of Land Management, Palm Springs-South Coast Field Office, for the portion of the movie filmed on lands administered by the BLM.

General Desert Tortoise Mitigation Measures

Worker Training

All workers shall be given special instruction on the desert tortoise prior to any filming activities occurring along Box Canyon Road. This instruction will include training on distribution, general behavior and ecology, protection afforded by State and Federal Endangered Species Acts (including prohibitions and penalties), and procedures for reporting encounters, and the importance of following the protection measures.

No New Surface Disturbance

No new surface disturbance allowed. Previously disturbed areas shall be used as worksites and for storage of equipment and supplies. No crushing or removal of perennial vegetation (i.e., shrubs) is allowed.

Biological Monitor

For activities conducted between March 15 and November 1, filming activities shall be monitored by a Qualified Biologist approved by BLM or the BLM Wildlife Biologist for the Palm Springs South Coast Field Office. The Biologist shall be present during all activities in which encounters with tortoises may occur. The Biologist shall watch for tortoises wandering into the filming areas, check under vehicles, and conduct other activities necessary to ensure that death or injuries of tortoises is avoided. All sightings of tortoises will be reported immediately to the BLM Wildlife Biologist. No touching, handling, collecting, or harassing of tortoises is allowed.

Refuse Disposal

All trash and food items generated by filming activities shall be promptly contained and regularly removed from the project site to reduce the attractiveness of the area to common ravens and other desert predators.

Dogs

No dogs allowed on site.

Motorized Access

Motor vehicle access shall be limited to maintained roads and designated routes. Be watchful for tortoises on dirt roads. If a tortoise is spotted by the film crew, it will be reported immediately to the BLM Wildlife Biologist.

- a. Speed Limits.** Vehicle speed within a project area, along right-of-way maintenance roads and on routes designated for limited use shall not exceed 20 miles per hour. Workers shall be made aware of these limits.
- b. Tortoises Under Vehicles.** Vehicles shall be inspected immediately prior to being moved. If a tortoise is found beneath a vehicle, the Authorized Biologist shall be

contacted to move the animal from harm's way, or the vehicle shall not be moved until the desert tortoise leaves of its own accord.
