City of Wildomar Insurance Requirements

Insurance requirements: As a condition of approval to issuance of a permit, a certificate of insurance will be required to include, but not limited to \$1,000,000.00 naming the City as a co-insured for protection against claims of third-party personal injuries, wrongful deaths and property damage.

Where aircraft is used in any production, either fixed wing or rotary, the limit shall be no less than \$5,000,000.00 per occurrence.

City officers, agents and employees shall be named as additional insureds and a certificate of insurance shall not be subject to cancellation or modification without 30 days' written notice to the City.

An applicant shall conform to all applicable federal and state requirements for Workers' Compensation Insurance as to all persons operating under a permit.

The certificate of insurance *and the Letter of Endorsement* (ISO form # CG-20-12-07-98 or AB-90-67-12-93 or equivalent) must name the City of Wildomar as an additional insured, as follows, verbatim:
